Radovan Karadzic arrested

Bosnian Serb war crimes suspect Radovan Karadzic, one of the world's most wanted men, has been arrested in Serbia after more than a decade on the run. The Bosnian Serb wartime political leader disappeared in 1996.

He has been indicted by the UN tribunal for war crimes and genocide over the 1995 massacre at Srebrenica. The European Union, which the new government hopes to join, has put Serbia under considerable pressure to hand over indicted war criminals to the UN tribunal in The Hague. But Karadzic's wartime military leader, Ratko Mladic, remains at large.

The arrest of Radovan Karadzic was welcomed by war crimes prosecutors in The Hague as a "milestone".

"Radovan Karadzic was located and arrested tonight (Monday evening, 21st July)" by Serbian security officers, a statement by the office of President Boris Tadic said, without giving details.

"Karadzic was brought to the investigative judge of the War Crimes Court in Belgrade, in accordance with the law on co-operation with the International Criminal Tribunal for the former Yugoslavia (ICTY)."

THE CHARGES

- Eleven counts of genocide, war crimes, crimes against humanity and other atrocities
- Charged over shelling Sarajevo during the city's siege, in which some 12,000 civilians died
- Allegedly organised the massacre of up to 8,000 Bosniak men and youths in Srebrenica
- Targeted Bosniak and Croat political leaders, intellectuals and professionals
- Unlawfully deported and transferred civilians because of national or religious identity
- Destroyed homes, businesses and sacred sites

Serbian government sources said he had been under surveillance for several weeks, following a tip-off from a foreign intelligence service.

Doctor of alternative medicine

Radovan Karadzic spent years living in Belgrade and practising alternative medicine, according to Serb officials. During a decade on the run, he had cultivated a long white beard and called himself Dragan Dabic, Serbian minister Rasim Ljajic said. Karadzic, 63, lived in a "very convincing" way using false papers, he said. He even gave public lectures and was a regular health magazine contributor.

"He was involved with alternative medicine, earning his money from practising alternative medicine... he was working in a private practice," said Mr Ljajic, the Serbian minister for relations with The Hague war crimes tribunal.

Karadzic's lawyer, Svetozar Vujacic, said that his client had lived in Belgrade for a considerable period of time, "while people who were in contact with him had no clue who he was".


"He did not have any security and he lived by himself" in New Belgrade, a modern suburb of large tower blocks, said Mr Vujacic. The lawyer said Karadzic was now looking like his old self after having a shave and a haircut at his own request.

Karadzic's assumed persona was so complete that he had a girlfriend, claimed to have grandsons living in the US and frequented a bar which sported pictures of himself and fellow alleged war crimes fugitive Ratko Mladic. The owner of The Madhouse bar, Misko Kovijanic, said Karadzic would often come in and drink red wine.

Persons Indicted For War Crimes (PIFWCs) - EUFOR Operations

EUFOR has operated since its inception in support of The International Criminal Tribunal for Yugoslavia (ICTY). The ICTY has indicted a total of 161 persons for serious violations of international humanitarian law in the territory of the former Yugoslavia and only two indictees remain at large as a result of the arrest of Radovan Karadzic on Monday 21st July 2008.

It has been the situation that EUFOR as was the case for its predecessors IFOR and SFOR, that all have been actively involved in supporting the ICTY in the identification and disrupting of support networks for fugitives, in a bid to close in and arrest PIFWCs.

Obviously an enormous amount of work is involved in each of the PIFWC Operations seen in the public raids, where evidence and information is gathered for further in depth analysis by police and ICTY.

The nature of PIFWC Operations, by definition requires strict Operational Security and as such they are probably only observed first hand by a few, but they are supported by many. However, these Operations are a good example of EUFOR's effectiveness in what is clearly a challenging aspect of the mission 'ALTHEA'.

Since EUFOR began in December 2004, we have been involved in over 20 PIFWC Operations, only made possible through the close cooperation and trust of a range of authorities and policing organisations, coupled with effective application of intelligence. This also includes cooperation with Serbian authorities who in the past two months have arrested two indictees (Zupljanin and Karadzic). This year EUFOR already undertaken 5 Operations. EUFOR Press Office Releases

indicate our PIFWC activities reported to the media this yearas follows:

- On 27th March at the request of the ICTY, EUFOR conducted a search operation in premises in Pale of people probably connected to the Radovan Karadzic support network. The aim was to find material or information. It is believed that these three people are associated with the Radovan Karadzic support network.
- On 2nd April at approximately 0530 at the request of the ICTY, EUFOR conducted a search operation in the premises of Dragan Draskovic in Krupac. It is believed that this person is associated with the Radovan Karadzic support network.
- On 22nd April at approximately 0600 at the request of the ICTY, EUFOR conducted a search operation in the premises of Goran Marinkovic in Koste Majkica, Paprikovac District. We believe Mr Marinkovic uses his extensive business links to fund the fugitives.
- On 30th May at approximately 0430 at the request of the ICTY, EUFOR conducted and focussed a search operation in the premises of East Sarajevo University, assigned to Mr Kosta Cavoski, in Pale. We believe Mr Cavoski uses his links with Pale to support the fugitive Mr Karadzic.

NB. This resulted in the local authorities, immediately prohibiting Cavoski's movements into BIH from Serbia.

- After the arrest of Stojan Zupljanin, on 11th Jun, the Commanders of NATO and EUFOR jointly announced 'they are delighted that their combined continuous efforts to identify, disrupt and close down the networks supporting PIFWCs contributed to the successful arrest of Stojan Zupljanin by Serbian authorities".

- On 15th July at approximately 0530 hrs at the request of the ICTY, EUFOR conducted an operation at the residence of Liljiana Karadzic, in Pale, with the aim of establishing what links and support the Karadzic family has with the PIFWC Radovan Karadzic, as well as identifying asset ownership.

- After the arrest of Radovan Karadzic on 21st July, The Commander of EUFOR welcomed the news of the arrest of war crimes fugitive Radovan Karadzic by Serbian authorities. The Commander said "this moment was significant for justice, for BIH, the wider Balkans and International Community. I also recognise the constructive steps taken by the new Serbian government".

..... and EUFOR continues in its work supporting the ICTY regarding the remaining two fugitives, Ratko Mladic and Goran Hadzic.

COM EUFOR Visits Cazin



At the moment there are 57 Romanian personnel serving in EUFOR in BIH in the Integrated Police Unit, Liaison Observation Team houses, Regional Coordination Centers and HQ staff.



Good Cooperation Between AFBIH and EUFOR

Lt Col Geert Lieverlo, thanked General Novakovic for his visit RCC1, whereupon they expressed their strong willingness and enthusiasm to reinforce the current relations, and to support each others armed force where possible in the future.

Exercises Conducted by MNBN

Between 14th and 18th July, EUFOR Multinational Battalion (MNBN) carried out exercise "BLUE SHARK III" at Archer Base and Rajlovac. The purpose of this training was both to maintain the capabilities of MNBN and to test the newcomers from the A Coy (Hungarian).

The Exercise was performed in two phases and it was executed in a fictitious scenario. During the first phase (14th -16th July) a Rapid Response Planning Process was executed by HQ MNBN. As a result, fragmentary orders were issued to all companies.

During the second phase (18th July) the Tactical Command Post (TCP) was deployed in Archer Base and three companies (A, B, D Coy) in Rajlovac training area.



After the end of the A Coy's entry training it was evaluated and the result was satisfactory. A Coy then achieved the Full Operational Capability (FOC).

B Coy acted as role-player in this fictitious scenario where a riot from D Coy against EUFOR personnel in a LOT house took place. Control Area Operations, Check Points, Green Box and Blue Box including Crowd and Riot Control (CRC) and other Peace Support Operations skills were carried out by A and D Coys. Lastly, an evacuation of EUFOR personnel exercise was executed by a Swedish Cougar helicopter.

CIMIC Actions of the Spanish Contingent

During July, the Spanish contingent undertook a number of CIMIC (Civil and Military Cooperation) assignments to benefit the population of BIH. These activities included:

- Delivery of a range of materials (combustibles for the heating, medicines, for office cleaning, bottled water, food and clothes) to the old asylum "Otac Kristofor" of the locality of Nova Bila. This institu-

tion is run by three Spanish nuns of Cordoba which has welcomed in about 80 older ones.

- On the 1st of July the Spanish language course 2007-2008 came to an end in the city of Mostar. This course comprises of the Cervantes Program, of diffusion of the language and Spanish culture, carried out by the Spanish contingent since 1999. This also took place in Trebinje and Bileca, with a total attendance of about 110 students divid-



ed into four levels of learning. Lt Col. Peñuelas, Commander of the Spanish Force in BiH, awarded certificates to each student "for its satisfaction and like recognition to the made effort".

- On the 1st and 9th of July, a delivery was made of clothes and footwear to the children of the orphanages "Egipatsko Selo" of Mostar and "Children's Home" of Sarajevo. This was donated by the Solidarity

International Foundation "Compañía de María" (FISC) of Cádiz (Spain).

- With typical character, every 15 days, the Spanish equipment LOT take food to a Bosnian family who live in the locality of Lubuski. They provide flour, oil and basic products to them.
- Delivery of a donation to the institution for the mentally handicapped "Mjedenica" of Sarajevo with the intention of financing an

excursion to the beach in September. The money was collected through contributions of the personnel of the Spanish contingent by means of the sale of handicraft products made in the institution workshops.

The Spanish contingent take great pleasure to be able to help these kind of people in BIH and we hope that the contributions serve to make the recipients just a little bit happier".

A raffle followed in aid of Mjedenica Education Center in Sarajevo and at sunset the event moved on with the opening of a fair. Whilst under the canopy people were given the opportunity to taste some typical Spanish food and a selection of beverages, including wine or "rebujito"

All people attending the event enjoyed the Spanish ambience, full of good humour, sevillanas and joy.

Freedom of movement of EUFOR personnel

EUFOR members remain in all circumstances and at all times under the exclusive jurisdiction of their respective national elements (Art.7 SOFA). This provision safeguards EUFOR personnel from any legal prosecution or punishment imposed by local authorities.

Due to recent frictions concerning border crossing, payment of highway fees and issuing traffic tickets, EUFOR Chief Legal Advisor met with representatives of BIH and Croatian authorities. This resulted in a mutual understanding for future procedures.

With regard to crossing the border to and from Croatia it was agreed that EUFOR personnel only have to produce their ID Card in order to be exempted from any further immigration or customs formalities (e.g. handover of passport). The EUFOR ID Card will be presented to verify the identity of a

holder. However, in no circumstances should anyone permit data stated at the ID Card to be recorded.

Furthermore, in case of the operational necessity EUFOR personnel

are also entitled to detour any vehicle convoys, with all warning hazards flashing,

> paying particular attention not to endanger other road users.

You should know that, based on the SOFA, EUFOR personnel (on presenting the ID Card) are allowed to use highways free of charge, no matter if they are using official EUFOR, rented or any other vehicle.

With reference to traffic violations (e.g. speeding) you are reminded that all EUFOR personnel have to respect the laws of BIH and the Republic of Croatia. However, local traffic police are not entitled to fine EUFOR personnel. Any violation of local law regulations will be reported to the respective Troop Contributing Nation (TCN), which is responsible to take appropriate measures against their respective member.

According to the General Framework Agreement for Peace in Bosnia and Herzegovina (GFAP), signed 1995, and the Status of Forces Agreements (SOFA) all EUFOR members enjoy the privilege of freedom of movement to ensure unimpeded and expeditious execution of the mission ALTHEA tasks (SOFA Art.9).

DCOM visit to RCC and LOT Houses

On 14th June 2008 DCOM EUFOR Brigadier General D'Alessandro visited LOT Houses under RCC 4 responsibility. He was accompanied by the new Chief IAD and the Chief LOT-Desk and their MA's.


The day started at LOT Zvornik where he received an overview of the work the Greek LOT members. Next was RCC 4 where he received a further briefing and finally was


the visit to LOT House Tuzla.


During the drive, the convoy stopped at distinctive points where a military geographical and historical appraisal was given by RCC Commander Colonel Teichmann.


The DCOM prior to leaving said he had the highest regard for RCC 4 and their ability to handle events such as Srebrenica anniversary.

Everything you need to know to get you moving

Every beginner asks at least a few of these questions at some point. Here are the answers:

How do I get started?


Start walking for an amount of time that feels comfortable - anywhere from 10 to 30 minutes. Once you can walk for 30 minutes easily, sprinkle one- to two-minute running intervals into your walking. As time goes on, make the running intervals longer, until you are running for 30 minutes straight.

Is it normal to feel pain during running?

Some discomfort is normal as you add distance and intensity to your training. But real pain isn't normal. If something feels so bad that you have to run with a limp or otherwise alter your stride, you're probably injured. Stop running immediately, and take a few days off. If you're not sure, try walking for a minute or two to see if the discomfort disappears. If it doesn't disappear, consult your GP.

Do I have to wear running shoes, or are other trainers fine?

Running doesn't require much investment in gear and accessories, but you have to have



a good pair of running shoes. Unlike all-round trainers, running shoes are designed to allow your foot to strike the ground properly, reducing the amount of shock that travels up your leg. They're also made to fit your foot snugly, which reduces the slipping and sliding that can lead to blisters.

What's the difference between running on a treadmill and running outside?

A treadmill 'pulls' the ground underneath your feet, and you don't meet any wind resistance, which makes running somewhat easier. Many treadmills are padded, making them a good option if you're carrying a few extra pounds or are injury-prone and want to decrease impact. To better simulate the effort of outdoor running, you can always set your treadmill at a one per cent incline.

Where should I run?

You can run anywhere that's safe and enjoyable. The best running routes are scenic, well lit, and free of traffic. There also soft: choose trails or smooth grass rather than roads. Think of running as a way to explore new territory. Use your watch to gauge your distance, and set out on a new adventure each time you run. Talk to other runners about the routes they run. The more varied your routes, the easier running will feel.

Should I breathe through my nose or my mouth?

Probably the latter, which will allow you to get as much oxygen as possible to your working muscles. However, some runners breathe through their noses during training runs, believing that this keeps them more relaxed. Do what works for you.

Seminar on protocol



The first seminar on the type of protocol to follow in EUFOR was held on 1st July in Camp Butmir. Protocol will determine what action needs to be taken in case of visits of V.I.P.'s, escorts to civil and military authorities, etc. and logistical organization.

The seminary was organized by the EUFOR Joint Visitors Bureau (JVB). After an introduction from the DCOM EUFOR, General Brigadier Roberto D'Alessandro, Chief of EUFOR JVB Major Paulo Concalves and his staff illustrated the content of the new handbook to be taken as reference for all future activities that require the use of the protocol.

Camp Butmir - EUFOR Disciplinary Standards

As with all Military Camps or Barracks, Camp Butmir prides itself on discipline.

Rules and regulations are there for a reason and it is very important that we establish a common standard for professional military conduct and discipline.

With 32 Nations and 500 civilians living and working in Camp Butmir discipline in is very important and where overall responsibility rests with the Camp Commandant and his Regimental Sergeant Major.

Some important reminders of what is expected are given below (SOP 3901 refers):

ID Cards

For security reasons, ID Cards must be carried at all times regardless of dress.

Dress and Military Bearing

Dress and bearing of military personnel is very important especially when in uniform. Some guidance; EUFOR personnel are not permitted to walk around the Camp with hands in pockets, smoking, improperly dressed or without wearing head dress.



Dining Facility

The rules of the dining facility are for our benefit and must be strictly adhered to in order that hygiene is of the highest order. Accordingly head dress must be removed in the dining facility and not be placed on dining tables. Similarly, clean and suitable dress is essential especially when wearing civilian clothes and those failing to achieve the required standard should be aware they may be invited to leave the facility. Finally, food is not permitted to be removed from the dining facility, again on grounds of food hygiene.

Accommodation Blocks

Firstly a major point on fire safety, smoking is strictly prohibited within accommodation blocks. Another key point to remember in accommodation areas is to have respect for other personnel living there which includes keeping noise levels down to a minimum in and around the blocks, and leaving the

showers and toilets in a clean condition.

Alcohol Consumption

Sensible drinking is permitted within the bounds of Operational, professional, health and safety, and national responsibilities and restrictions.

Final Comment by RSM


Following the above straightforward reminders will go a long way to ensuring all personnel enjoy their tour of duty.


